PRINCIPAL'S REPORT (Evan)

- 1. Evan shared that the team is currently on pace in all grades.
- 2. Evan shared that attendance has improved slight from 67 students at risk to now 62; however, this is still up from 41 students last year at this point.
- 3. Evan reported that student enrollment was at 366 FTE for Survey 3.
- 4. Evan requested approval from the Board for removal of a school bus that no longer works. The Board asked Evan to reach out to more businesses to see if the bus has any value and report back to the Board with additional information at the March Board Meeting.

MANAGEMENT REPORT – (Dan)

- Monthly financial reports for January 2022
 Jim noted that the finance committee met at 6:50 before the regular meeting and found the January financial statements in good order. Dan commented that the January financial statements reflected a YTD surplus of \$99,000 before adjustments for the lower February 2022 FTE count.
- Budget Update
 Based upon the lower February FTE count and what appeared to be a reduction in the funding level for FEFP, Dan stated that the budget would need to be revised in the March 2022 board meeting after getting more feedback on the FEFP funding.

- Facility expansion update
 The school does not have a final response from Duke Energy. Next update in March.
- Acknowledgement of the annual corporate filing and terms of the board members
 Dan confirmed that they annual corporate filing was complete. Board member positions were confirmed.

NEW BUSINESS

- School Administrator/ Link-Up Review
 The Board conducted the annual review for Link-Up and Dan Rishavy as administrator. It was noted that all required reporting to the FDOE, the school district and to the board were timely and complete. Dan continued to work on the school expansion on behalf of the school. Information was provided about the data-dashboard advancements. The Board agreed unanimously that services were satisfactory and to extend the last year of the 3-year agreement, as provided for in the agreement. This extension brings the agreement through June 30, 2024.
